

2022 CLEVELAND AUTO SHOW OFFICIAL VEHICLE LEASE GIVEAWAY

OFFICIAL CONTEST RULES

THE FOLLOWING RULES APPLY TO THE 2022 CLEVELAND AUTO SHOW OFFICIAL VEHICLE LEASE GIVEAWAY CONTEST AT THE CLEVELAND AUTO SHOW, FEBRUARY 25- MARCH 6, 2022. FAILURE TO MEET ALL REQUIREMENTS MAY DISQUALIFY FINALISTS/WINNER FROM PRIZE. PLEASE READ ALL RULES.

1. NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.
2. Void where prohibited. Contestants may register by:
 - i) Filling out an entry blank daily at the Greater Cleveland Automobile Dealers' Association contest booth at the Auto Show at the I-X Center, February 25- March 6, 2022. One winner will be drawn each day at the show's designated closing time. Entries submitted after show closing time will be entered for the following day.
 - ii) Entries for the final drawing day (March 6, 2022) must submit their entry by 4:00pm EST with a live drawing taking place at 5:00pm EST. The grand prize winners on the final drawing day must be present to win.
 - iii) Mailing a postcard containing name, address, telephone number and age to 2022 CLEVELAND AUTO SHOW OFFICIAL VEHICLE GIVEAWAY C/O Cleveland Auto Show, 9150 South Hills Blvd, Suite 150, Broadview Heights, Ohio 44147. Mail-in entries will be entered upon receipt.

Entry blanks void if received outside authorized channels. All in-person and mail-in entries must be handwritten; no mechanically copied entries accepted. Deadline for receipt of mail-in entry is March 2, 2022. Only one entry per person per day. Entrants may not utilize two forms of entry on the same day. All entries become property of Sponsors and will not be returned. Sponsor is not responsible for lost, late, illegible, misdirected, damaged or postage-due mail.

3. There will be two grand prize winners at the Cleveland Auto Show. One winner will receive a thirty-six-month lease on a 2022 Hyundai Sonata SE (MSRP \$25,590). One winner will receive a thirty-six-month lease on a 2022 Honda Ridgeline Sport (MSRP \$38,865). These vehicles are subject to change. Vehicles on display at Auto Show in contest area may not be the actual vehicles awarded. Leases will be based on 12,000 miles per year. Winner will be responsible for \$.20 per mile thereafter. Winner may be liable for excess wear and tear to vehicle. Sponsors shall not have any responsibility or liability whatsoever for any property loss, damage, personal injury, or death, in connection with the prize provided pursuant to the Giveaway and/or any person's participation in the Giveaway; provided, however, that Hyundai Motor Company and Honda Motor Company shall be solely responsible for any express written limited warranties specifically set forth in the applicable Owner's Guide for the respective vehicles. Winner must take delivery of prize from the automobile dealership designated by Sponsor. Sponsor shall not be responsible for delays in delivery of the prize vehicle, and delivery is subject to availability. Sponsor, however, shall use all reasonable efforts, subject to availability, to deliver the Grand Prize vehicle to the Sponsor-designated delivery dealer within three hundred sixty (360) days of completion of verification process. Winner shall bear all risk of loss or damage to the vehicle after it has been delivered to the winner. Winner must personally retrieve the Grand Prize vehicle within thirty (30) days of written notification of delivery or he/she will lose his right to claim the Grand Prize vehicle. Winner will be required to enter into a lease or use agreement as directed by Sponsor in order to claim his/her prize. Winner may also be requested to complete additional forms as requested by the entity providing the vehicle lease in order to claim their prizes. GRAND PRIZE WINNERS MUST HAVE MINIMUM CREDIT SCORE OF 650 AND QUALIFY FOR CREDIT THROUGH HONDA FINANCIAL SERVICES OR THROUGH HYUNDAI MOTOR FINANCE. GRAND PRIZE WINNERS WHO DO NOT QUALIFY THROUGH HONDA FINANCIAL SERVICES OR HYUNDAI MOTOR FINANCES (Respectively based on vehicle won) WILL RECEIVE A ONE TIME PAYMENT OF \$5,000.00 IN LIEU OF THE GRAND PRIZE LEASE.

Winner is solely responsible for all gasoline, vehicle maintenance, and any other costs incurred in claiming, registering, or using the prize including without limitation, all taxes, title, license and registration fees, if applicable. Sponsor reserves the right to change product specifications at any time without incurring any obligations. No assignment, transfer, conversion to cash or cash redemption or substitution of the prize is permitted, except Sponsor reserves the right to substitute the prize with a prize of comparable or greater value should the prize become unavailable. Winner is not eligible for any cash back or rebate which may be available on the vehicle at time of delivery. All other costs and expenses not specified herein, if any, are the responsibility of the winner. Any difference between the approximate value and the actual cost of the prize will not be awarded. Winner agrees that Sponsor, and General Motors have neither made nor are responsible or liable for any warranty, representation, or guarantee, express or implied, in fact or in law, relative to the prize, including but not limited to its quality, mechanical condition or fitness except for any express written limited warranties specifically set forth in the applicable Owner's Guide for the vehicle.
5. Starting February 25, 2022 and ending on March 6, 2022, one (1) entry per day will be randomly drawn from daily entries received to qualify as a finalist. All finalists will be notified and it is their responsibility to be at the Auto Show at 4:00p.m. on Sunday, March 6, 2022 for the final contest random drawing to award the grand prizes. There will be two grand prize winners. Each finalist will be given two (2) keys, one for the 2022 Hyundai Sonata SE and one for the 2022 Honda Ridgeline Sport. If your key opens either vehicle, you win the lease described above for that vehicle. Lease won may not be substituted. Finalists are not required to purchase an auto show admission ticket for final contest drawing. Odds of winning depend on number of eligible entries received.
6. In the event of the winner's failure to qualify or claim the grand prize within 30 days of being notified the prize is ready for delivery, an alternative winner may be drawn from those who qualified as finalists. Should that winner fail to claim the prize within 30 days of being notified, no prize will be awarded. In no event will Sponsors award more prizes than listed in these Official Rules.

Employees, officers and directors of the Cleveland Auto Show, Greater Cleveland Automobile Dealers' Association, Honda Motor Company or Hyundai Motor Company ("Honda", "Hyundai" or "Prize Supplier") and its members, employees of any new or used motor vehicle dealership, automobile manufacturer, their advertising agencies (collectively, the "Sponsors") and their immediate families and household members are ineligible to win.
